### **Database**

**Data type:** Annual relational database on Executive and Non-Executive Directors in Nordic Listed Companies

**Population**: Publicly listed companies in the Nordic countries. For 2006-2019, this is defined as companies listed on the Nasdaq stock exchanges and the Oslo Børs.

Data frequency: Annual financial reports

Data unit: Individual level

Countries: Denmark (DK), Sweden (SE), Norway (NO), Finland (FI) and Iceland (IS).

**Time Period:** 

2006-2019: Executives, Board Members, Ownership, Companies

**Abstract:** This database includes annual observations on Top Executives and Non-Executive Board Members of all listed companies in the Nordics; Denmark, Finland, Iceland, Norway, and Sweden from 2006-2019, with gaps. The data uniquely identifies firm level board member characteristics, such as gender, age, role within board (chairperson, vice chairperson), representation (employee representation), election term, executive and non-executive directors compensation and board committee participation.

The data was collected through various data sources and methods and ultimately harmonized, and quality checked.

election_form	election by either general assembly or employee elected.	
independent	Denotes whether a director is independent of the company.
